- ◆ General Involved in international and domestic mediation and arbitration in commercial, investment disputes; involved in litigation in construction and commercial disputes in Hong Kong and acted as advocate in international commercial and investment arbitrations. Appeared in various levels of court in Hong Kong including the Privy Council (prior to 1997) and the Court of Final Appeal.
- ◆ Arbitrations Acted in arbitrations relating to construction/engineering, shipping, technology transfer, merger and acquisition, share purchase, coal mining, general commercial and international trading disputes. Some awards that have been challenged in court and therefore can be referred to are, for instance :
  1. Shimizu Corporation v. The Attorney General (re Queen Mary Hospital): acted for the AG.
  2. S.Y. Engineering Co. Ltd. v. Hong Kong Housing Authority (re Ma On Shan Site): acted for the Hong Kong Housing Authority; SY challenged the Award but was unsuccessful.
  3. Covington Marine Corporation and Another v. Xiamen Shipbuilding Industry Co. Ltd. [2005] EWHC 2912: acted for the shipbuilder.

- ◆ Acted as sole arbitrator, as Chair of Arbitral Tribunal and party-appointed arbitrator in many domestic and international commercial and investment arbitrations involving disputes in construction/engineering, insurance, shipping, financial instruments, technology transfer, IT, oil and gas/exploration, merger and acquisition, joint venture/shareholder disputes, international trade and sale of goods.

- ◆ Acted as mediator in Hong Kong Airport Core Projects disputes and government infrastructure projects, construction, shareholders and private commercial sector disputes.
